Message from the Staff

Four Lake Authority has been blessed with strong partnerships and associates which have provided positive results for our citizens and region. The results were facilitated by a streamlined Board of Directors that provides enhanced leadership to serve Macon, Smith, Sumner, Trousdale, and Wilson Counties. The Board has responded to numerous special-called meetings to assist tenants and economic development actions. The Board has been fiscally responsible while being assertive with economic development projects to improve our business development tool box.

Major activities during the fiscal year included:

Beginning with the 2012/2103 fiscal year, a newsletter, "The Board Room," was developed and distributed quarterly to keep the Board of Directors informed and updated on the Authorities activities.

August, 2012 Four Lake moved into a new office on Highway 25, providing additional space with a conference room.

In December, 2012, Four Lake utilized its Department of ECD grant to award a \$417,000 fiber optics contract to Tri-County Electric. This will connect the Four Lake office and PowerCom Industrial Center with fiber optics and expedites the process to service Hartsville and Trousdale County.

In order to advance networking and stronger relationships, Four Lake hosted a luncheon in Nashville for the Board of Directors and the Tennessee Department of ECD in February, 2013.

In April, 2013 each of Four Lake's five counties completed their Letter of Support for the Alternative Site Framework as part of the Nashville Foreign Trade Zone#78 application. This process involved our Economic Development Advisory Committee, The Board and staff, working with Nashville Mayor Dean's Office and the Nashville Chamber, in a team effort that will compliment recruitment and operations of companies working in the import/export business.

Also in April, Four Lake assisted Middle Tennessee Industrial Development Association with research and distribution of MTIDA's 2013 Community Data Profiles.

A twenty-one acre site located in the PowerCom Industrial Center was submitted for the "Select Tennessee Site Certification" program. Four Lake hosted a site visit in April and continues to collect the Round 2 data requests.

May 21, 2013, the Four Lake staff appeared before the Tennessee General Assembly Government Joint-Committee for a Sunset Review Hearing; the Four Lake Regional Industrial Development Authority received a recommendation for an extension of four years.

May – June, 2013, Four Lake worked with a realtor in recruiting Zwirner Equipment to Hartsville. The Four Lake Board approved the purchase and renovation of the former SteelTek property to facilitate new jobs and activate an empty industrial building.

Four Lake was issued an Aquatic Resources Alteration Permit by the Tennessee Department of Environment & Conversation for the port at PowerCom Industrial Center.

To date, Four Lake has provided \$41,955.55 funding to its region through grant programs developed to assist certified sites and economic development projects.

Four Lake joined the Tennessee Economic Partnership as an investor to promote marketing and recruitment for jobs and new investments.

Together, Don and Charly attended over eighty conferences, events, and meetings for economic development, chambers, JECDB, and others in the past six months.

Improvements to the PowerCom Industrial Center have advanced throughout the year with paving, clearing & development, to additional security fencing. Currently, engineering and bid requests have been released for sewer installation in Village One. Also, negotiations with V&C/Christy's are underway for additional building improvements. Four Lake looks forward to new challenges, as well as conclusion for several ongoing projects.

Plans are being made to initiate dredging for the PowerCom port facility, begin renovations for the Zwirner Equipment Building, and to explore marketing strategies & rebranding opportunities. With the new fiscal year 2013/2014, Four Lake's accounting process will be converted to QuickBooks Premier and staff will continue the oversight & management of the PowerCom Industrial Center. Four Lake will work to represent the five county region conveying information, prospects, and opportunities to Macon, Smith, Sumner, Trousdale, & Wilson Counties.

This Annual Report reflects an overview of endeavors and achievements of fiscal year 2012-13. We acknowledge that any success the Four Lake Authority has achieved was the result of working together with numerous agencies, elected officials, and community leaders. All of whom aspire to build stronger communities by attracting jobs and cultivating economic development for the enrichment of our citizens and the next generation. We appreciate the efforts of the educational and workforce development entities to prepare our communities with the expertise and skills required for global competition.

Thank you for allowing the staff to serve the leadership and citizens of the Four Lake Region - we appreciate your time and guidance. Four Lake will continue, diligently, to be good stewards of its region's resources.



2013/2014 Work Plans

Economic Development Program

- Maintain communications with CCA emphasizing the need to fulfill obligations pledged by both Four Lake and CCA while encouraging the continuation of the project.
- Continued involvement with RPO and TDOT for the completion of the Hwy 141 project.
- Pursue opportunities to expand Four Lake's footprint throughout the five-county region by assisting individual counties in economic development projects.
- Continue to market available buildings and properties at the PowerCom Industrial Center (PCIC), including affiliated website updating.
- Continue infrastructure and facilities development for the PCIC (electrical, water/sewer, telecommunications, fiber optics, and building & road upgrades).
- Arrange for site improvements as required for incubator clients, as well as prospects.
- Provide technical assistance to incubator clients as required (financing, marketing, etc.).
- Maintain and promote partnership & cooperation among elected officials, economic development organizations, and Chambers of Commerce in the region.
- Continue to fine-tune Concept Maps for the PowerCom Industrial Center.
- Finalize Restrictive Covenants for the PowerCom Industrial Center.
- Management of the Zwirner Equipment property located in the Hartsville Industrial Park.
- Initiate dredging and partner with the Corps of Engineers on plans for a Cumberland River dock/barge access at PowerCom Industrial Center.

Business Development Assistance Program

- Continue to provide support for the SBA's TN Small Business Development Centers.
- Continue to support small business development seminars and referrals throughout the five counties.

Workforce Development Program

Continue to market training services (TTC/Hartsville, VSCC, and TTU) to business and industry in the region.

Program Administration

- Comply with reporting requirements of the State of TN (Sunset Review & State Funding Board), Board of Directors, funding agencies, and others as necessary.
- Convert accounting system to QuickBooks Premier with the new fiscal year.
- Maintain financial reporting and controls.
- Explore marketing strategy and rebranding opportunities.
- Maintain and continually upgrade Four Lake's website www.fourlake.org.
- Manage the daily operations of the office.
- Oversight & management of the PowerCom Industrial Center.
- Maintain professional relationships with member governments, funding agencies, TN Dept. of ECD, and other related entities such as Chambers of Commerce, UT/CTAS, the Greater Nashville Regional Council, the Middle Tennessee Industrial Development Association, the Upper Cumberland Development District, TN Economic Development Council, TVA, and the region's electric distributors.

Other

- Continue to serve as the liaison with North Central Solid Waste Planning Region (NCPR), the TN Dept. of Environment & Conservation, and Development Districts.
- Support the updating, printing and distribution of Community Data Sheets for the twelve targeted communities in the Four Lake region.
- Increase public awareness of the Four Lake Authority and its vision for the region.
- Pursue other regional development opportunities as directed by the Board of Directors.
- Aggressively pursue new projects and tenants.
